## **Research Policy**

## 1. Aim & Scope:

The research policy of the college aims to inculcate research culture amongst the faculty members, Ph.D scholars, M.Phil Scholars, PG and UG students. The College has developed excellent facilities, both in terms of academics and infrastructure. Mannar Thirumalai Naicker College encourages faculty members and students to undertake sponsored research projects from Government and Non-government agencies with a commitment to serve the society. The college has established a system to promote research policy and offer administrative and financial support.

## 2. Objectives:

- ❖ To improve the quality of research.
- ❖ To encourage the faculty members to apply for major and minor research projects in various funding agencies.
- ❖ To promote students to apply for student research projects.
- ❖ To facilitate seed money to faculty members and students for initiating research.
- ❖ To stimulate Interdisciplinary/ Multidisciplinary research.
- ❖ To motivate the faculty members and scholars to publish in UGC Approved journals/ UGC CARE List/ Scopus/ Web of Science/Peer-reviewed journals.

## 3. Institutional Regulations:

### (i) For Ph.D., Scholars

- ❖ Permission from the Principal shall be obtained through Research Committee for Ph.D., full time/Part time Scholars Registration.
- ❖ Attendance is mandatory for Ph.D., full time Scholars on all working days and it is maintained by the respective research department.
- ❖ Ph.D., full time Scholars may be availed maximum of 12 days Casual Leave in the academic year.
- ❖ Ph.D., full time Scholars who attend conferences, workshops, literature survey and data collection should get prior permission in the prescribed format for providing leave on Other Duty (OD), failing which their attendance will be marked as absent.

- ❖ The presence of Ph.D., full time Scholars is mandatory for all Ph.D Viva Voce examination, colloquium and research related programmes organized by Research Centres & other disciplines in the campus.
- ❖ Ph.D full time/Part time Scholars payment of fee on time is mandatory as per Madurai Kamaraj University regulations.

**(ii) For Research Supervisors and Heads of the Research Department**

- ❖ The Research supervisor should strictly follow the guidelines of Madurai Kamaraj University from the period of Ph.D scholar's registration till the date of award.
- ❖ The Research supervisor should instruct their candidates to complete **Course Work/Present their work in front of Doctoral Committee for every six months / Submission of Biannual Report / Payment of fee** etc on time.
- ❖ The Research supervisor is expected to submit the copy of evidence to the research Committee regarding the following
  - Guide recognition/registration certificate
  - Ph.D scholar registration confirmation order
  - Pre-Submission presentation
  - Thesis Submission Certificate
  - Ph.D Viva –Voce examination
  - Ph.D degree (Syndicate Communication letter copy and Degree Certificate)
  - Research proposals (Submission)
  - Research Project Sanctioned details
  - Research Project midterm and final project reports to the funding agencies
- ❖ **The heads of the Research Department have to follow the research centre renewal process every year.**

**4. Guidelines for M.Phil, Programme and Doctoral Programme in the college**

**(i) Admission for M.Phil, Programme**

- ❖ There are three full time M.Phil., programmes - Commerce, English and Mathematics in the campus.
- ❖ Candidates are allotted according to the norms and regulations followed by MKU.

- ❖ PG degree with 55% of marks and passing of Pre-registration Qualifying Entrance Examination in the respective programme conducted by MKU are mandatory for M.Phil programme admission.

**(ii) M.Phil Dissertation**

- ❖ Dissertation work is a partial fulfillment of the requirement for the award of the M.Phil degree programme. M.Phil scholars have to carry out dissertation work under the supervision of the research guide as per Madurai Kamaraj University.
- ❖ Last date for submission of dissertation and Viva-voce examination should be announced by the office of the Controller of Examinations.
- ❖ M.Phil scholars have to present their research work at the time of Viva-voce examination in the presence of External Examiner. The dissertation will be evaluated by both Internal Examiner (Research Guide) and External Examiner. The project work marks may be awarded based on the performance of the dissertation work and Viva-voce examination.

**(iii) Admission for Doctoral Programme:**

- ❖ PG degree with 55% of marks (with M.Phil or without M.Phil) and passing of Pre-registration Qualifying Entrance Examination in the respective programme conducted by MKU are mandatory for Ph.D programme admission.
- ❖ Candidates aspiring for admission to Ph.D. programme in Mannar Thirumalai Naicker College shall submit his/her application with relevant certificates to the Principal in the prescribed format and the same shall be forwarded by the respective supervisor and Head of the Department concerned.
- ❖ Candidates may register either as full time or part time scholars.
- ❖ Call letter will be issued to the candidate to appear before selection Committee for the interview and selection will be intimated shortly.
- ❖ Candidates must submit the offline/online application enclosed with relevant certificates and selection letter to Madurai Kamaraj University.
- ❖ Candidates registration for the research programme, course work, duration of research, extension, relaxation, change of guide, change of title, publication, presentation, Pre-Submission presentation, synopsis submission, submission of thesis and Viva-Voce examination should be followed as per MKU guidelines.



## 5. Institutional Policy for Promotion of Research:

### (i) Financial assistance Seminars / Conferences / Workshops

- ❖ Financial assistance (Complete / Partial) is provided by the management to organize National/ International Conferences, Seminars or workshops.
- ❖ To enhance research culture in the institution, the registration fee is provided from UGC Autonomy Grant for the aided streams and for self-financing stream from the management fund for presenting research papers in National/International Conference/Seminar organized by various **Colleges/ Universities**.
- ❖ The institution provides travelling allowance (Complete / Partial) for presenting research papers abroad and for attending the interview on Major/Minor research projects funded by various agencies.
- ❖ Self-financing staff members who are awarded Ph.D., and who have cleared SET / NET examinations get increment.
- ❖ The institution provides Institutional Mail id for faculty members to promote the publication metrics.

### (ii) Research Seed Money

- ❖ The institution provides **Institutional Sponsored Faculty Research Project Grant** to the faculty members who submit proposal with Socio-economic; creative and innovative research work every year.
- ❖ The institution provides **Institutional Sponsored Student Research Project Grant** to a team of **UG students / PG students / Ph.D., Scholars** under the guidance of a research project supervisor of the corresponding department every year.

**(iii) Composition of Research Committee:**

- Principal – Chairperson
- Dean of Research – Convener
- Faculty Members from various disciplines (Maximum 7 members)

**(iv) Functions of the Research Committee:**

- ❖ The Research Committee of the college shall be responsible for implementing the research policy of the college
- ❖ The Research Committee monitors and addresses the issues related to research.
- ❖ The Research Committee continuously encourages the staff members to take up research projects in their respective fields. It sends circulars to all the faculty members when funding agencies call for the Research Project Proposals.
- ❖ The Research Committee collects and maintains data related to research supervisors list, scholars details and research activities.
- ❖ Formation of Research Advisory Committee (External). The Research Advisory Committee is made up of members of the various Universities/Colleges representing subject areas selected by the Research Committee.
- ❖ Conducts Research Committee meeting periodically for the execution and upgradation of research policy.
- ❖ Call for Institutional sponsored faculty and student research project under the scheme of seed money provided by the management, scrutinize and recommend proposals submitted.
- ❖ Prepares budgets for seed money and other research related activities.
- ❖ Make efforts to improve the availability of research infrastructure requirement.

**6. Code of Ethics**

**(i) Plagiarism check**

Our College Library is equipped with plagiarism checker (**Software - Grammarly**) to check the originality of research. Our college offers plagiarism checker software with free of cost to all the Researchers.

**(ii) Code of conduct**

- ❖ Ethics and plagiarism are the significant components in the research project and publication.
- ❖ The Research Committee checks the plagiarism percentage of the Institutional Sponsored research project proposals. The scrutinized and selected research proposals are sent to the Research Advisory Committee (External).
- ❖ The Research Advisory Committee (External) has the power to recommend the deserved Research proposal. The Committee will be asked to ensure that the proposal under consideration is congruent with ethical considerations identified by the Advisory Committee. The Research Committee announces the selected research projects and the management sanctions the seed money for research.
- ❖ After submitting the Institutional Sponsored Research Project, the research committee again monitors the plagiarism, and then the Research Advisory Committee (External) evaluates the Institutional Sponsored Research project. The Research Advisory Committee (External) will submit the final report copy to the research committee.
- ❖ Based on the Research Advisory Committee (External) report, the research committee prepares and distributes the project completion certificate seeking permission from the principal and the management.
- ❖ Organizes workshop and seminars to promote the research ethics of publications, patent and project proposals.
- ❖ The Project Guide and Scholars are asked to use the plagiarism checker (**Software-Grammarly**) available at our campus.
- ❖ Code of Ethics for Research Degree Programmes is maintained:
  - to check the quality
  - academic standards of the research degrees
  - to provide regulatory information and guidance for research scholars & faculty members.
- ❖ To attain these features our College strictly follows the Regulations of Madurai Kamaraj University.

(Amendment from the academic year 2021 -2022)

As per the recommendations of Research Committee meeting, the following amendments will be implemented in the Research Policy from the academic year 2021 -2022.

### I. Amendment in Research Seed Money

To Introduce **Institutional Sponsored Inter-departmental Research Project** as a new category for Research seed money for developing Multi/Inter Disciplinary research in the college campus.

### II. Amendment in Code of Ethics

1. All Institutional Sponsored faculty, student and Inter-departmental Research Project proposal and final project report output for research seed money should be free from plagiarism or within the permitted level.
2. All Research Project proposals submitted to various funding agencies should be free from plagiarism or within the permitted level.
3. Certificate of plagiarism check will be issued with free of cost by the Main Library of our college. It is mandatory for
  - ❖ submission of Institutional Sponsored faculty, student and Inter-departmental research project proposal for research seed money.
  - ❖ submission of Institutional Sponsored faculty, student and Inter Departmental Research project final output for research seed money.
  - ❖ getting **Endorsement Certificate** from the Head of Institution to apply for research project to various funding agencies.



4. In addition, Research Ethics Committee will be created for monitoring the research ethics in our college campus and in order to protect dignity, rights and welfare of research participants.
